The following regulations regarding the operation and parking of motor vehicles must be strictly followed. Any violation could result in revocation of the privilege to operate or park a motor vehicle on school premises.

1. Only vehicles bearing a current Montague High School registration sticker may be operated and parked by students on school property. The vehicle registration sheet must be completed, signed by the student and parent/guardian, and returned to the high school office. Any misrepresentation made by a student on this document will result in disciplinary action. **There will be a \$10 vehicle registration fee (per vehicle) each school year. A new form must be filled out each year.**
2. Students must park their vehicles **only** in the designation parking lot. Any student vehicle parked in an area other than the designated parking lot will **be subject to towing at student and/or parent/guardian expense.**
3. Vehicles are to be locked during the school day and neither the driver nor any other student is to sit in a vehicle during the school day or lunch periods. Students may not drive cars on or off school grounds at any time during the school day or during lunch periods without the consent of the principal.
4. Students are to operate their vehicles in a safe and careful manner at all times. Violations, such as speeding, careless or reckless use of a vehicle in any way, or violation of any state law or local ordinance, could result in revocation of the student's driving and parking privilege on school property. Police referrals will be made when appropriate.
5. If a student operates or parks a vehicle upon school property, this constitutes the consent of the student and his/her parent/guardian to the search of the vehicle by school officials or police officers, regardless of whether there is reasonable suspicion to conduct a search. A search may include the passenger compartment, engine compartment, trunk, and all containers (locked or unlocked) in or on the vehicle.

As a condition of the above named student being granted the privilege to operate or park the registered vehicle on school property, the undersigned agree to all the conditions set forth above, including Regulations 1 through 5. We agree and understand that any violation of the aforementioned Regulations will result in revocation of this privilege and constitute grounds for discipline of the above named student. We expressly consent to search of the vehicle as described in Regulation 5. The undersigned parent/guardian grants permission for the student to operate and park the registered vehicle upon school premises subject to the Regulations set forth herein.
